First AAL call attracts 117 proposals

(16 September 2008) The first call for proposals (AAL-2008-1) of the Ambient Assisted Living Joint Programme has attracted 117 transnational project proposals. Organisations from all AAL Partner States are represented in AAL proposals and project coordinators stem from 19 countries of the 23 AAL Partner States. 950 partners are counted in the transnational project proposals. Total costs of some 370 Mio € were indicated and 230 Mio € are requested as public funding, i.e. short below 2 Mio € per project proposal on average. The total request constitutes a four times oversubscription compared to an announced indicative total funding of 57.7 Mio €. The final selection of the projects is scheduled for 20 and 21 October at the General Assembly of the AAL Association, i.e. the legal entity that is responsible for the AAL Joint Programme. The Ambient Assisted Living Joint Programme is a joint research and development (R&D) funding activity by 20 European Member States and three Associated States with the financial support of the European Community based on article 169 of the EC Treaty.

Broadband Internet for all Europeans: Commission launches debate on future of universal service

(25 September 2008) How can the EU achieve that all Europeans – from the North of Finland to the South of Italy, from the Western Ireland to Eastern Romania – have access to broadband Internet? This is the main question raised in a Commission report today. From 2003-2007 broadband use in the EU tripled to 36% of households. However, 7% of the EU's population are still not connected (30% in rural areas). There are striking gaps in the EU: 100% of the population is covered in Denmark, Luxembourg and Belgium, but more than 60% in Romania (75% in rural areas) do not have broadband access. Even in strong economies such as Italy and Germany, 18% and 12% respectively of the rural population are not covered. With broadband increasingly important in daily life, policy tools like radio spectrum management and mobile satellite services should accompany a broad debate about the universal service in telecoms – a safety net guaranteeing a minimum level of services, such as connection to a phone network and basic Internet access, filling basic needs that the market does not.

Commissioner Reding will underline the importance of self-regulation and will also meet representatives of the social networking companies Myspace and Dailymotion.

Participants will have an opportunity to exchange know-how and best practices on ways of making Information Communications Technology (ICT) and online services more accessible and inclusive for all citizens.

"eInclusion of immigrants and ethnic minorities" workshop

13 November 2008 Brussels, Belgium

This new ePractice.eu workshop will explore immigrants and ethnic minorities issues in relation to three key themes: Theme 1: Local community development and entrepreneurship. This will focus on how ICTs are being used to support challenges that are faced by some communities with regard to poor economic opportunities; low levels of digital literacy and e-skills and issues around social cohesion. It will explore in particular how ICTs are being used to develop individual and social capital and community capacity, and to support entrepreneurship. Theme 2: Language and identity in a culturally diverse Europe. Language is a complex and contested issue in e-inclusion. On the one hand, ICTs are being deployed to promote 'multi-lingualism' – for example to help new immigrants improve their job opportunities by learning the language of the 'host country'. On the other, they are being used to promote a different inclusion agenda – that of promoting cultural diversity by preserving the culture and language of 'minority' and therefore excluded cultures. This theme will reflect on these issues as well as related issues around 'identity' within a European society, and how identity is itself being re-shaped through ICTs. Theme 3: Introduction initiatives and services, inclusive eGovernment and participation. This theme will focus particularly on the problems faced by newly-arrived immigrants and how ICTs can be used to better support their integration.

This national conference is organized by the Coordinating Office Information Society in the Federal office of Communications (OFCOM) in collaboration with the Members of the network "Swiss Digital Integration". The objective of the

The focus will be on certain groups of society that are still not using the ICT, such as older people, migrants and the disabled.
